Board of Selectmen May 10, 2016

Chairman Joseph Pacheco called the meeting to order at 6:30 p.m. Present were Joseph Pacheco, Karen Roberts and Marie Smith.

Acceptance of the Minutes

Mrs. Smith motioned and Mrs. Roberts seconded to accept the minutes of the May 3, 2016 meeting as printed, Mr. Pacheco made it unanimous.

Public Hearing – Application for Transfer of a Class III Motor Vehicle Junk License – Joseph Costa III d/b/a Rose's Used Auto Parts, 1 East Britannia St.

Mr. Joseph Costa III was present to address the Board to request the change. Seeing no questions or opposition, Mrs. Smith made a motion to approve the change, Mrs. Roberts seconded and Mr. Pacheco made it unanimous.

Department Heads & Committees

Chief Jim Januse was present to update the Board on the Activity Report for the month of April. Fires, fire incidents, mva investigations, and public assist were 83; Ambulance, medical emergencies mva's and public assist were 169; Miscellaneous inspections, fire alarm work and items of note were 70; Mutual aid fire and ambulance, 16 ambulance given, 7 ambulance received; 9 fire given, 5 fire received for a total of 37. ~There were a total of 952 calls for April, 2016 which is 47 less than last year. ~Chief Januse updated the Board on several employees who are out on extended sick leave. He also noted there was a very bad car accident that took place on North Main Street recently.

Student Government Day will be held on Thursday, May 19th at 9:00 a.m. The dedication of the Town Report Ceremony will be held on Tuesday, May 24th at 7:00 p.m. at the Selectmen's Meeting. This year's dedicatee is Don McKinnon.

The SERSG DPW Supplies Contract Award Sheet was received and discussed. Mrs. Smith made a motion to approve, Mrs. Roberts seconded and Mr. Pacheco made it unanimous.

The SERSG Paper Supplies Contract for W.B. Mason was reviewed and discussed. Mrs. Smith made a motion to approve, Mrs. Roberts seconded and Mr. Pacheco made it unanimous.
