May 17, 2016

Chairman Joseph Pacheco called the meeting to order at 7:00 p.m. Present were Joseph Pacheco and Karen Roberts and Marie Smith.

Acceptance of the Minutes

Ms. Roberts motioned and Mrs. Smith seconded to accept the minutes of the May 10, 2016 meeting as printed, Mr. Pacheco made it unanimous.

Department Heads & Committees

Mr. Tim Inacio, Director of Planning & Development was present to address the Board. The owners of Bassett Knoll Estates have met with Conservation Commission to see if the Town will hold the conservation easement on the property. On Whippoorwill Estates the applicants are pulling building permits for the final phase. On Forge Estates, a potential 40B project, has been continued till June 15th for a ZBA meeting. The new Shell/Season's Market opened on May 7th and Planning Board required the applicant to install a guard rail and will require a sign off from them. Mr. Inacio has reached out to MassDot engineers who are working on the Center St. traffic signal project and they expect the project to begin in late September or early October. Also, he is working on a memo regarding two House Bills which are designed to streamline the building process. Also, he discussed the resurfacing of Rt. 138 and has reached out to MassDot for updates on that project. He also discussed hazardous trees in open space and is looking at how other communities have resolved that issue.

Town Administrator's Report

Mr. Buckner reviewed the Town Administrator's Report. He wanted to thank all who turned out for the Annual and Special Town Meetings.
