### Board of Selectmen

July 26, 2016

Chairman Joseph Pacheco called the meeting to order at 7:00 p.m.  
Present were Joseph Pacheco and Marie Smith.

### Acceptance of the Minutes

Mrs. Smith motioned and Mr. Pacheco seconded to accept the minutes of the July 12, 2016 meeting as printed. Approved 2-0.

### Appointments

At the request of Chief Donovan, Mrs. Smith moved and Mr. Pacheco seconded to appoint the following three individuals as Special Police Officers: Ashley L. Correia, Jonathan L. Fillmore and Jared Turkington. All three have completed the 356 Hour Basic Reserve Intermittent Training Academy. Approved 2-0.

### Department Heads & Committees

Director of Planning and Community Development Tim Inacio gave his monthly written planning report to the Board. Highlights include completion of Hutch Motor Sports, Kennedy Plumbing and Shell Seasons Market. Skyline Marble and Granite is undergoing site plan review for a location on Broadway. Orchard Street/Rt. 44 intersection is nearing completion as is the bridge deck replacement on the Rt. 138 overpass at I-495. South Coast Rail Project has been delayed by 7 years. New development at the old Bradford Trailer Sales lot is under preliminary review.

### Town Administrator's Report

Mr. Buckner reviewed the Town Administrator's Report. There will be no Selectmen's Meeting next week, being on the summer schedule.

The next Selectmen's Meeting will be August 9th with Department Head Bob Iafrate on the agenda.

### Correspondence

The Board was notified of a vacancy in the elected Raynham Housing Authority due to the resignation of Earl Marsh. The Board requested interested citizens to submit letters. Appointment will be until the next town election.
