- Mr. Daniel Andrade informed that correspondence will be forwarded to developers of Doe Run subdivision regarding the surety bond and the snow plow account.

Community Members present via GoToMeeting:

Mr. Bill Shearstone, 45 Cardinal Circle, was present and asked for an update on the road for their neighborhood. Mr. Daniel Andrade informed that Steve Ventresca of Nitsch Engineering along with Mr. Iafrate and the Raynham Highway Superintendent met with the developer. The solution that was discussed was to cut back the driveways and repave the apron portion, which should be done in April due to the weather. The developer is also hiring an engineer to redesign areas that may cause issues.

Ms. Kim Jacques, 135 Cardinal Circle, was present and thanked the Board for the update. She informed that her driveway has already been cut back. Mr. Daniel Andrade discussed the process that the developer has agreed upon and noted that each driveway will be viewed individually. No work will move forward until the Building Inspector, Planning Board, Highway Superintendent and Nitsch Engineering signs off on the plans.
