ADVERTISEMENT FOR BIDS  
ROUTE 44 PUMP STATION DIESEL TANK REPLACEMENT

Sealed Bids for the construction of the "Route 44 Pump Station Diesel Tank Replacement" project. Bids will be received by the Raynham Sewer Department, 416 Titicut Road, Raynham, MA 02767 until 2:00 p.m. local time on September 14, 2023 at which time the Bids received will be publicly opened and read. Sealed Bids must have outer envelope marked as "Town of Raynham, Route 44 Pump Station Diesel Tank Replacement, Raynham, Massachusetts".

The work consists of the demolition and disposal of the existing 2,000-gallon vaulted aboveground storage tank, associated structure, and buried piping. Provide a backup generator system or additional fuel storage for the operation of the existing generator while the tank is being replaced. Installation of a new 1,500-gallon double-wall storage tank, associated double-walled flexible piping, and fuel tank monitoring system. Bids shall be on a lump sum basis as indicated in the bid form.

All Bids for this project are subject to the provisions of Massachusetts General Laws Chapter 149, Section 44A - 44J inclusive.

In accordance with Section 44D of Chapter 149 of the General Laws of Massachusetts as amended, the prospective General Bidders must submit with their Bid, a certificate of eligibility issued by the Division of Capital Asset Management and Maintenance (DCAMM), showing that the Bidder has been approved to bid on projects of the size and nature as advertised herein. Prospective General Bidders must also submit an updated statement summarizing their record for the period between the latest DCAMM certificate and the date of the Bid submittal. The DCAMM certificate of eligibility to be submitted by the General Bidder shall be for the category of work defined as "General Building Construction".

Prospective bidders must complete a one-time registration process on the web site in order to receive log-in credentials. A deposit shall be furnished in accordance with the Instructions to Bidders.

Minimum Wage Rates as determined by the Commissioner of Department of Workforce Development under the provision of the Massachusetts General Laws, Chapter 149, Section 26 to 27D, as amended, apply to this project. It is the responsibility of the Contractor, before Bid opening, to request, if necessary, any additional information on Minimum Wage Rates for those trades people who may be employed for the proposed Work under this Contract.
