Insurance Requirements

This information is provided as reference material only. The full text of the by-law can be found at www.town.raynham.ma.us.

Each licensed contractor shall acquire and continually maintain while licensed hereunder liability insurance coverage on all personnel and equipment to be used in the Street Opening work which insurance is to be with insurance companies licensed to do business in the Commonwealth of Massachusetts and shall contain the following coverage and be in the following minimum amounts:

Commercial General Liability Insurance including operators, independent contractors, complete operations, XCU hazards, broad form property damage and personal injury.

General aggregate: \$1,500,000.00

Products and complete operations

Aggregate \$1,000,000.00

Each occurrence \$1,000,000.00

Combined single limit \$2,000,000.00.

Automobile Liability Insurance covers owned, non-owned and hired vehicles.

Bodily Injury Liability \$ 500,000.00 each person, \$1,000,000.00 each accident

Property Damage Liability \$ 300,000.00 each accident

Combined Single Limit \$2,000,000.00

The Licensee agrees to maintain at the Licensee's expense all insurance required by law for its employees, including disability, workers compensation and unemployment compensation.

Certificates of Insurance shall provide for at least thirty days' notice to the Awarding Authority of cancellation or material change.

The Inhabitants of the Town of Raynham shall be listed as an additional insured and certificate holder on the Certificate of Insurance to be provided by the Applicant. The Awarding Authority is not responsible for any loss or damage whatsoever to the property of the Licensee.
